PREDICTION OF HEAD AND NECK CANCER WITH INFLUENCE OF CELESTIAL BODIES - A CASE STUDY

Medical astrology (traditionally acknowledged as iatromathematics) is an original medical system that connects with different parts of the body, illnesses, and medicines as under the effect of the stars (Nakshetra) and planets that may give the results according to his Karma (work) already done in the pre- birth and the present movement. Each of the astrological results influenced by the location of the stars and planets is linked with illnesses including malignancy of divergent parts of the human body. This study has tried to show the liaison of medical and astrological science to justify how the planets are responsible cause for the head & neck cancer in human being. It has also displayed the correlation between the medical astrology with head & neck cancer disease. The random sampling of the cancer individuals diagnosed histopathologically was selected for the study purpose. INTRODUCTION

Head and neck cancer is a group of cancers that starts in the mouth, nose, throat, larynx, sinuses, or salivary glands etc. The annual incidence of head and neck cancers worldwide is more than 650,000 cases with around 330,000 deaths each year. Male to female ratio ranges from 2:1 to 4:1. About 90% of all head and neck cancers are squamous cell carcinomas (HNSCC). HNSCC is the sixth leading cancer by incidence worldwide. Similarly, 57.5% in Asia and largely in India (20 per 100000 population). In Nepal 2015, total 9718 new cancer cases were reported by hospital based national cancer registration programme. Whereas, 1882 (19.3%) were head & neck cancer. There were only 1363 (19.2%) out of 8729 cases in 2011 and 1401 (19.4%) in 2012. Similarly, 1741 (19.9%) and 1868 (20.3%) cases of head & neck cancer were diagnosed for 2013 and 2014. Now days, head & neck cancer disease is increasing per day. The main factors of cancer increase are considered to be the use of tobacco, poor -hygiene, alcohol, betel, HPV-infection. The research done in the past shows the cancer causal-factors that one of the planets. This study have done regarding epidemiological concern, tries to display astrological risk factors and the connection of head & neck cancer and the astrological views. Astrology is a kind of science. It is considered as the light of knowledge. As light shows the objects lying in the darkness so does astrology predicts the person's future activities. And it offers guidelines as for possible. Prakashan, Baranasi, India, 2016:2). In the context of the random sampling of twenty patients among them some have taken treatment and some have other curative, palliative and supportive management. Different horoscopes and Lagna Kundali were analyzed and the difference has been studied for the head & neck cancer problem on the basis of astrological influence has been analyzed. The research of the disease and the astrological thought, the relation can be between the disease and astrology. As is seen as to what the person is influenced to the disease, it can attack it, which is the saying of the astrology. The astrological horoscopes can assume the reason of the disease. To show the inter connection between the medical science and astrology is the study which can be called medical astrology.

MATERIALS AND METHODS

The random sampling of the individuals visited hospital for head & neck cancer disease treatment has been selected for the study. By taking informed consent, total twenty cancer disease treating individuals were selected for the Kundali. RESULTS

This study explains the twenty cases based on the Lagna Kundali through the interaction made on the head and neck cancer - patients and their horoscopes are made to identify the case on the main point of the position of the Planets which influence the birth.

➤ Case number 1: The Lagnes of Birth-chart was Jupiter placed at 1th house in Sagittarius zodiac sign, astrologically this house is known as the Lagna. The Rahu placed at 2nd house in Carpi corm which gives full sight to 8th house this house considered as a causal of death, pain and chronic disease. The Lord of second house was Saturn placed at 6th house in Taurus. The Lord of 6th house was Venus placed with moon and Ketu at 8th house in Cancer zodiac sign and fully suffered by Saturn. Similarly, the Lord of 8th house was the Moon placed with Ketu and Venus in Same house (8th house), same zodiac (Cancer zodiac sign) and fully victimized by Saturn. The Lord of 12 house was Mars placed with Sun (Surya), and Mercury at 9th house in Leo and fully sighted by Jupiter

Note: The Venus was suffered by Ketu and Taurus Zodiac sign was victimized by Saturn.

➤ Case number 2: The Lagnes of Birth-chart was Moon placed at 11th house in Taurus. The Marak placed with Jupiter and Mercury at 12th house in Gemini and fully suffered by Rahu. The Saturn placed at disease house in Sagittarius and the Lord of 6th placed at 12th house. The Lord of 8th house was Saturn placed at 6th house and reciprocal with Jupiter.

Note: The Venus victimized by Mars, whereas the Mars situated as a descend position.

➤ Case number 3: The Lagnes of the Lagna Kundali was Saturn place at 4th house in Taurus and reciprocal with Jupiter. The Ketue placed at 6th house in Cancer zodiac sign and the Lord of 4th house Moon placed at 7th house with Sun, Venus and Mercury which was fully suffered by Rahu. The Lord of 8th house was Mercury placed at 9th house in Libra and fully suffered by Rahu. The 12th house was occupied by Mars and Rahu. Whereas, the 12th Lord placed at 4th house.

Note: The Taurus zodiac sign victimized by the Saturn and Venus victimized by Rahu.

➤ Case number 4: The Lagnes of the Lagna Kundali was Jupiter placed with Venus and Moon at 12th house in Aquarius and fully suffered by Ketu. The Marak planet (Mars 0 co-jointly placed with Saturn at 4th house in Gemini. The Lord of 6th house was Sun placed at 2nd house in Aries. The Lord of 8th house was Venus placed at 12th house and fully suffered by Ketu. The Lord of 12th house was Saturn placed at 4th house with Mars.

Note: Taurus zodiac sign victimized by Ketu.

➤ Case number 5: The Lagnes of the Lagna Kundali was Saturn co-jointly present with Moon at 7th house in Leo zodiac sign and the Lagna was fully suffered by Saturn. The Lord of 2nd house was Jupiter placed with Sun, Mars and Mercury at 11th house in Sagittarius. The Lord of 6th house was Moon co-jointly place at 7th house in Leo. The Lord of 8th house was Mercury placed at 11th house. The Lord of 12th was Saturn placed with Moon.

Note: The Venus situated as a pap-kartari position (surrounded by sinful planets).

> Case number 6: The Lagnes of birth- chart was Saturn cojointly placed at Lagna in Carpi corm and fully seen by Rahu. The Mars placed at 2^{nd} house with Venus and Mercury and the Lord of second was also the Saturn. The Roges present at 2^{nd} with guru-mangala (Mars and Jupiter). The Lord of 8^{th} was Sun co-jointly placed with Venus at 3^{rd} house house in Aries and fully suffered by Saturn. The Lord of 12^{th} was Jupiter placed with Mars and Mercury at 2^{nd} house.

Note: The Venus victimized by Saturn.

➤ Case number 7: Lagnes of the birth - chart was Mercury placed with Sun, Moon and Venus at 12th house in cancer zodiac. The Lord of second house was Moon placed at 12th house with Sun, Venus and Mercury. The Lord of 6th was Mars placed at 10th house which give full sight to Lagna. The Lord of 8th was Saturn placed at same house and give full sight to mars (at 10th house) and 2nd house (at Marak bhava). The Lord of 12th house was Venus placed at same house in Taurus.

Note: Smell causal factor nos , Lord of Lagna Mercury, Gimini zodiac victimized that occur problem on nose.

➤ Case number 8: The Lagnes of birth-chart was Mercury co-jointly present with Sun at 12th house in Taurus and fully suffered by Rahu and Saturn. The Moon placed at 2nd house in Cancer zodiac and the Lord of second house was also Moon placed at same house. The 3rd house was occupied by Rahu, Saturn, Mars and Jupiter and fully seen by Ketu. The Lord of 6th house was Mars placed with Jupiter, Saturn and Rahu at 3rd house in Gemini and fully seen by Ketu. The Lord of 8th house was Saturn placed with Jupiter and Rahu in 3rd house. The Lord of 12th was Venus placed at Lagna.

Note: Taurus zodiac placed at 12th house. Whereas, the tangle of 6th, 8th,12th house consider as a negative fruit.

➤ Case number 9: The Lagnes (Sun) placed at 8th house in Pisces which was fully suffered by Mars. The Lord of 2nd was Mercury co-jointly placed with Jupiter at 7th house in Aquarius. The Lord of 6th house was Saturn placed at 11rd house in Gemini. The Lord of 8th was Jupiter co-jointly placed at 7th house in Aquarius. The Chandra, Mangala and Ketu (Moon, Mars and Ketu) were placed at 10th house in Taurus and fully suffered by Rahu. The Saturn placed at 11th house in Gemini which fully sights the 8th house. Whereas, the 8th house consider as a long term disease house also seen by Rahu. The Lord of 12th house was Moon co-jointly placed with Mars at 10th house in Taurus.

Note: The Taurus zodiac victimized by Mars.

➤ Case number 10: The Lagnes (Mars) placed at Lagna in Scorpio which give full sight to the 8th house. The Lord of 2nd house We Jupiter co-jointly placed with Ketu and fully sighted by Rahu. The Venus co-jointly placed with Saturn at 6th house I aries. The Lord of 6th was Mars placed at Lagna in Scorpio zodiac sign. The Lord of 8th was Mercury placed at 7th house in Taurus. The Lord of 12th house was Venus co-jointly placed with Saturn at Aries.

Note: The Astamesh (Mercury) placed at the Taurus zodiac sign.

➤ Case number 11: The Lagnes of the Lagna Lundali was Venus placed at Lagna in Libra. The Lord of 2nd house was Mars co-jointly placed with Mercury at 12th house in cancer Zodiac sign. The Lord of 3rd house was Jupiter also placed at 12th house in the same zodiac sign. placed The

Lord of 6th was Jupiter placed at 4th house in Capricorn. The Lord of 8th house was placed at Lagna. The ord of 12th was Mercury placed with Mars at 12th house in Cancer zodiac and fully seen by Jupiter.

Note: Gemini zodiac sign victimized by Saturn. Mercury has relationship with Gemini, Mars and Mercury co-jointly present in same house (12th house).

➤ Case number 12: Lagnes of the birth-chart was Saturn placed with Moon, Mercury and Venus at 9th house in Libra and fully suffered by Ketu. The Lord of 2nd house was Jupiter placed at 6th house in cancer zodiac and fully suffered by Mars. The Roges (Lord of 6th house) placed at 9th house with Saturn, Mercury and Venus and fully sighted by Ketu. The Lord of 8th was Mercury placed at Bhagya − Bhava (at 9th house) with Saturn, Venus and Moon in Libra this house was fully suffered by Ketu. The Lord of 12th was Saturn placed at 9th hopuse with Venus,Moon and Venus this house was victimized by Saturn and fully seen by Ketu.

Note: Gemini zodiac victimize by Ketu. Mercury suffered by the Saturn.

➤ Case number 13: The Lagnes of the birth-chart was Mercury co-jointly placed with Sun at 6th house in Scorpio and fully seen by Ketu. The Saturn placed at 2nd house in Libra, this house is known as a Maraka and the Saturn give full sight to 8th house. Whereas, the 8th house considered as a long term disease or house of chronic disease and occupied by Jupiter as a reciprocal position with Saturn. The Lord of 6th house was Saturn placed at 2nd house in Libra. The Lord of 8th was Mars placed at 7th house in Pisces. The Lord of 12th was Sun co-jointly placed with Mercury at disease house in Aquarius. The Saturn placed at 2nd house and the Jupiter placed at 8th house. Whereas, the Saturn and Jupiter was in reciprocal position.

Note: Gemini zodiac suffered by Mars. Triangle of 3, 7, 11 relation with Sun and Saturn.

➤ Case number 14: The Lagnes (mercury) co-jointly Placed with sun at 6th house in Scorpio and fully sighted by Ketu. The Ketu placed at 2nd house and the Lord of second was Moon co-jointly placed with Saturn at 5th house in Libra and fully sighted by Jupiter. The Lord of 3rd house was Sun co-jointly placed with Mercury at 6th house in Scorpio and fully sighted by Ketu. The Lord of 6th was Mars placed with Venus and Rahu at 8th house in Carpi corm and fully seen by Ketu. The Lord of 8th house was Saturn co-jointly placed with Moon at 5th house in Libra. The Lord 12th was Venus placed with Mars and Rahu at 8th house and fully sighted by Ketu.

Note: Mercury co-jointly present with Sun at 6th house. Mercury just near of Sun which cause fair and affect the Karaka-organs.

➤ Case number 15: The Lagnes of the birth chart was Saturn co-jointly placed with Rahu at 9th house in Libra and fully seen by Ketu. The Moon placed at Lagna in Saturns's house (Aquarius) and fully suffered by Rahu. The Maraka planet (Jupiter) placed at 5th house in Gemini. The Ketu placed at 3rd house in Aries and fully seen by Saturn. The Lord of 5th house was Mercury placed at 12th house in Carpi corm and fully sighted by Ketu. The Roges (Moon) was placed at 1st house and fully suffered by Rahu. The Lord of 8th was

Mercury placed at 12th house in Carpi corm and fully sighted by Ketu.

Note: The Lord of Gemini, Mercury placed at 12th house. Third house suffered by Ketu. In the tangle of 3,7,11, the Saturn and Rahu in same direction.

➤ Case number 16: The Lagnes of birth-chart was Jupiter placed at 7th house with Sun, Mars and Moon at 7th house in Virgo. The Ketu placed at Maraka house. (Second house) in Aries which gives full sight to 8th house. Whereas, the Venus co-jointly placed with Rahu. The Lord of 6th was sun placed at 7th house with Guru, Chandra and Mangala (with Jupiter, Moon and Mars) at 7th house in Virgo. The Lord of 8th was Venus co-jointly placed with Rahu at 8th house in Libra and fully seen by Ketu. The Saturn placed at 9th house in Scorpio which give full sight to disease. The Lord of 12th was Saturn placed at 9th house in Scorpio.

Note: The Lord of second house victimized by Rahu.

➤ Case number 17: The Rahu co-jointly placed with Mercury at Lagna in Virgo. The Lagnes (mercury) was co-jointly Placed with Rahu at 1st house in Virgo and fully seen by Ketu. The Lord of 2nd was Venus co-jointly placed with Mars at 11 houses in cancer zodiac. The Lord of 6th was Saturn placed at 3rd house in Scorpio. The Lord of 8th was Mars co-jointly places with Venus at 11th house in Cancer zodiac sign. The Lord of 12th was Sun placed at 12th house in Leo and fully suffered by Saturn. Whereas, the Sun and co-jointly placed with Jupiter at 12th house in Leo.

Note: Lord of Gemini (Mercury) victimized by Rahu.

➤ Case number 18: The Lagnes of the birth-chart and the Roges was Mars Placed at 12th house in Libra. The lord of 2nd house was Jupiter co-jointly placed with Moon at 5th house in Pisces and fully suffered by Saturn. The Lord of 8th house was mercury placed at 11th house which was fully sighted by Ketu. The Lord of 12th was Venus co-jointly placed with sun at 10th house in Leo. The Ketu placed at 2nd house which give full sight to 6th and 8th house which was consider as a Maraka planet also. The Lagna was in a Kartari condition by sinful planet.

Note: The Rahu places at Gemini in 8th house. So Gemini victimized

➤ Case number 19: The Lagnes of the birth chart was Sun co-jointly placed with Mercury at 12th house in Cancer zodiac sign and fully suffered by by Rahu. The Lord of 2nd house was Mercury co-jointly placed with sun at 12th house in cancer zodiac sign. The Lord of 2nd consider as a Marak placed at Baya-bhav anf fully suffered by Rahu. The Saturn placed at 7th house and give full sight to the Lagna. The Lord of 6th and 7th house was Saturn placed at 7th house in Aquarius. The Lord of 12th house was Moon placed at 8th house in Pisces which was in Kartari of sinful planets

Note: Taurus was suffered by Mars.

➤ Case number 20: The Jupiter and Ketu placed at Lagna in Taurus and fully suffered by Mars and Rahu. The Lagnes of Lagna Kundali was Venus placed at 3rd house in Cancer zodiac sign and fully sighted by Saturn. The Mars and Saturn were co-jointly placed at disease house in Libra. The Lord of 6th house was Venus placed at 3rd house in Cancer zodiac and fully suffered by Saturn. The Lord of 8th was Jupiter co-jointly placed with Ketu at Lagna in Taurus

and fully seen by Rahu. The lord of 12^{th} was Mars placed with Saturn at 6^{th} house in Libra.

Note: Sinful planet are in the tangle of 3,7,11 being in same direction suffered the Venus.

DISCUSSION

In recent days, the observation of the data of the head & neck cancer shows its increasing condition. Even in Nepal, the head & neck cancer is giving to increasing rapidly. According to the medical science, the poor hygiene, alcohol, tobacco use, HPV infection are its major factors. In this regard, the celestial planets are thought to influences the human body. Some research, too, shows the planets responsible to grow the cancer in the human body. Therefore, this study exhibits the relation for head & neck cancer incidence. Every human bodily organ has their own causal-planet system. According to the nature of that planet, the disease, too, comes to occur when the native is susceptible to any kind of the disease. If any is susceptible to the cancer and is exposed to any other cancer-risk-factor, then possibility of the cancer seems to be there.
